Kidney and Pancreas Referral Criteria

- 1. Indications for Transplant: Any condition that results in end-stage renal disease, including, but not limited to:
 - a. Kidney
- 1. Diabetes mellitus
- 2. Hypertension
- 3. Glomerular disease
- 4. Tubular and interstitial diseases
- 5. Reno-vascular and other vascular diseases
- 6. Congenital, rare familial and metabolic disorders
- 7. Re-transplant/ graft failure
- b. Pancreas
 - 1. Type 1 Diabetes Mellitus
 - 2. Hypoglycemic Unawareness
- 2. Absolute contraindications include, but are not limited to:
 - a. Advanced cardiopulmonary disease
 - b. Active malignancy with the exception of basal or squamous skin cancer
 - c. Severe local or systemic infection
 - d. Active substance addiction/abuse
 - e. Major psychiatric illness that cannot be managed sufficiently to allow post-transplant care and safety
 - f. BMI >45
- 3. Relative Contraindications include, but are not limited to:
 - a. Multiple urinary tract reconstructions
 - b. Lack of social support
 - c. Severe malnutrition/cachexia
 - d. Evidence of significant non-adherence
 - e. Moderate Cardiopulmonary disease
 - f. BMI 40 45
- 4. Indications for Inclusion in Incompatible Kidney Transplant Programs (Kidney Transplant Only):
 - a. The candidate must meet one or more of the following criteria:
 - 1. Transplant candidate makes antibody to one or more of the donor's antigens (HLA or non-HLA)
 - 2. Transplant candidate has incompatible blood type with donor.
 - 3. Transplant candidate has an unacceptable mismatch with the intended donor and requires placement in the kidney paired donation (KPD) program.
 - b. The candidate must have an identified living donor who has completed the second phase of testing.

- 5. Substance Use Disorder Policy: The candidate cannot be actively abusing drugs or alcohol.
- 6. Compliance: The candidate must have a history of consistent compliance with the treatment regimen.
 - a. Assessment by social worker and multidisciplinary team during initial evaluation
 - b. Compliance issues are addressed with a compliance-monitoring program on a case by case basis.
 - c. Written or verbal reports are required from health care team regarding compliance with treatment regimens:
 - 1. Keeping appointments
 - 2. Taking medications as prescribed
 - 3. Attending dialysis as scheduled
 - 4. Following the prescribed diet and fluid restriction
